



46th White Lake Water Festival

May 17 & 18, 2024

FOOD VENDOR APPLICATION

You are invited to participate in the 46th White Lake Water Festival scheduled for Saturday, May 18, 2024 at Goldston's Beach in White Lake, North Carolina. Vendors will be set up for Friday evening and all-day Saturday.

The vendor fee for a 10 X 10 booth space is \$75 until April 1, 2024. Each additional 10 X 10 is another \$75. After April 1st, the fee will be \$95.00. Your space reservation must include storage. The fee is nonrefundable due to inclement weather. Vendors are responsible for their own set up including tents, tables, and chairs and clean up. Set up times for vendors by 3pm on Friday and Saturday from 7am until 9am. All vendor vehicles are expected to be parked in the designated vendor parking area by 9am. Beware that vendor parking will be further away, you will be transported back to the vendor area after you move your vehicle. We do not provide electricity and generators are prohibited inside the festival site unless given permission by the committee prior to the event. Food vendors may also be placed at Goldston's Beach or other sites along White Lake Drive. Food vendors must NOT leave the area dirty or with spills. If you do you will be charged a clean up fee of \$50 (payable to Jake Womble) and put on the do not return list. No Wifi is available in the area.

We would like to offer a large variety of foods, snacks and beverages. We do however have a non-competitive selection process. Food vendors must submit a list of items indicating their specialties with prices. Once approved, Food Vendors must provide proof of insurance and obtain a Temporary Food Establishment permit form the Bladen County Environmental Health Division. First step is to contact Bladen County at (910) 862-6852. Download the Bladen County Health - TFE Permit.

Each vendor will assume liability for any and all damages done to his/her facility, goods/services, equipment and injuries to any Festival participants. Furthermore, vendors shall hold harmless the Festival, its Directors, Staff, etc. of all claims, fees, cost, expenses, and damages. All taxes are the sole responsibility of the vendor.

Booth assignments may change as the site layout is prepared. Therefore, we do not mail booth assignments in advance of the date of the festival. Our volunteers will be available to direct you to your space the morning of the event!
